## Recovery Act Background

On February 17, 2009, the President signed Public Law 111-5, the Recovery Act. Federal Acquisition Regulation (FAR) interim rules were published in the Federal Register on March 31, 2009, in FAC 2005-032, providing authorities, policies, and procedures for government-wide implementation of the Recovery Act and for special contract procedures contained in the OMB Guidance. The interim rules immediately make available FAR contract clauses to include in Government Contracts. The clauses added/updated pertain to any Order (new or existing orders that are modified) that is funded in whole or in part with Recovery Act funds.
